


# COMPANIONING THE DYING AND THE BEREAVED:

This workshop explores the challenge of coming alongside someone who is facing end of life loss or who has recently suffered a death in the family and is grieving that loss. It addresses what such a journey looks like and provides insight for those family and professionals who give love and care to those at the "end of life" or in bereavement.

The tenets of companioning

This workshop will address both anticipatory grief—looking ahead to an impending loss, the issues of impending loss, the struggle to come to terms with death over time, both for the dying person and the family, and bereavement grief—when a death has occurred.



- Anticipatory grief is still grief
- Anticipatory grief does not preclude bereavement grief
- Anticipatory grief is a family/community event
- How anticipatory grief affects treatment
- How anticipatory grief affects the reality of "end of life"
- How anticipatory grief affects the caregiver and patient decision making and treatment collaboration

We will challenge the notion that, though words have their place and are significant in our connection with others, they are not always required, that silence or "showing up" in someone's pain is often more desirable and even more powerful in bridging the gap between caregiver and patient/grieving friend.

We will look at the effects of loss on the whole person and ask the questions, "Are there stages through which every bereaved individual passes? What can I expect is 'normal' grief? Do men and women grieve differently?"
